PLEASE TAKE NOTICE THAT on November 6, 2015, at 1:30 p.m., or as soon thereafter as the matter can be heard, before the Honorable Dana M. Sabraw in Courtroom 13A of the United States District Court for the Southern District of California, located at 333 West Broadway, San Diego, California 92101, Plaintiff SERGIO PERALTA ("Plaintiff") will, and hereby does, move the Court for an order approving Class Counsel's request for an award of \$270,000 in attorneys' fees and at least \$13,645.62 in costs² as a part of the Settlement reached in this matter.³
