- 2. This Court has jurisdiction over the claims of the Class Members asserted in this proceeding and over all parties to the action.
- The Settlement Agreement is hereby deemed incorporated herein as if expressly set forth, and has the full force and effect of an Order of this Court. The Settlement Agreement shall be enforced according to its terms.
- 4. For the reasons set forth in the Preliminary Approval Order and in the proceedings of the Final Approval hearing, which are adopted and incorporated herein by reference, this Court finds that the applicable requirements of the California Code of Civil Procedure § 382 have been satisfied with respect to the Settlement Class and the Settlement Agreement. The Court hereby makes final its earlier provisional certification of the plaintiff class, as set forth in the Preliminary Approval Order. The Court finds that the settlement is fair, adequate, and reasonable, and falls within the range of reasonableness.
- 5. The Court concludes that the Settlement Administrator, Phoenix Settlement Administrators, took all reasonable and necessary steps to locate and notify each class member of the Settlement Agreement. The notice given to the Class fully and accurately informed the Class of all material elements of the Settlement Agreement and their opportunity to object or comment thereon; was the best notice practicable under the circumstances; was valid, due and sufficient notice to all Class Members; and complied fully with the laws of the State of California and other applicable law. The notice fairly and adequately described the Settlement and provided Class Members adequate instructions and a variety of means to obtain additional information. A full opportunity has been afforded to Class Members to participate in this hearing, and all persons wishing to be heard have been heard. Accordingly, the Court determines that all Class Members who did not timely and properly request exclusion are bound by this Judgment.

- 13.
