**Plaintiff Rocio Canseco's Motion for Preliminary Approval of Class Settlement**

The Court received and reviewed the supplemental filings of 6/1, 6/5, 6/13 and 6/14/18 and thanks counsel and the parties for their efforts. The motion for preliminary approval is **granted**.

For final approval as to the proposed enhancement, counsel should state the amounts the representative is expected to recover as a class member, and any other factors pertinent to the enhancement request. The high, low, and average recoveries for the class members as a whole should also be stated.

For final approval as to the fee and cost requests, evidence should be presented as to the services provided by counsel, including time records, to allow the Court to evaluate the lodestar, and as to the basis for the costs claimed, including supporting documentation for all claimed costs. Plaintiffs' counsel

must also either address any fee-splitting arrangement with any other counsel, or confirm that there is none. (See CRC 3.769(b), and *Barnes, Crosby, Fitzgerald & Zeman, LLP v. Ringler* (2012) 212 Cal.App.4th 172, 184.) The Court will reserve any decision on fees, costs, administrator costs, and enhancements until the final fairness hearing: preliminary approval should not be construed as approval of those sums.

The Status Conference is scheduled for 08/21/2018 at 01:30 PM in Department CX101.

Counsel to file an updated status conference report five court days prior to the next hearing.

Counsel may telephone the court to continue the status conference on this and the related cases to coincide with motion for final approval, once the motion is filed.

Clerk to give notice to plaintiff and plaintiff to give notice to all other parties.
