- 15 1. The "Final Hearing" shall be continued from June 21, 2018 to July 5, 2018 at 10:00 a.m.
16 to be held at the JAMS San Francisco Resolution Center, Two Embarcadero Center, Suite
17 1500, San Francisco, California, to determine whether the proposed settlement of this
18 arbitration is fair, reasonable and adequate and should be finally approved. The Arbitrator
19 will also consider at the Final Hearing whether applications for Claimants' Counsels'
20 attorney fees and expenses and incentive award to the representative Claimants should be
21 granted and, if so, in what amounts

23 2. The hearing continuance does not extend the claim, objection, or opt-out deadlines.
24 3. Claimants' briefs and papers in support of the proposed settlement, and application for an
25 award of fees and expenses to be filed with the Arbitrator seven (7) calendar days prior to
26 the Final Hearing.
