	[PROPOSED] ORDER APPROVING REQUEST FOR FEES, COSTS, AND INCENTIVE PAYMENTS		

On June 25, 2018, a hearing was held on Plaintiffs' motion for fees, costs, and incentive payments associated with the PAGA-only Settlement as to the Adult Content Liability Release Claims against defendants Google Inc. and Alphabet Inc. (collectively "Google"). The Court having considered all papers filed and proceedings herein and otherwise being fully informed, and having made this Order, and good cause appearing,

IT IS HEREBY ORDERED:

- 1. Plaintiffs' Counsel is awarded attorneys fees in the amount of \$346,118.20;
- 2. Plaintiffs' Counsel is awarded litigation costs in the amount of \$7,207.50.
- 3. Plaintiffs are awarded incentive payments in the amount of \$1,000 each.

The above amounts shall be paid from the common fund created by the PAGA-only Settlement approved in conjunction with Plaintiffs' motion for fees, costs, and incentive payments. Plaintiffs are directed to submit a copy of this Order to the LWDA within 10 days of the date of this Order.
