[PROPOSED] AMENDED FINAL APPROVAL ORDER AND JUDGMENT

1 On September 27, 2023, the Court entered the Order Granting Motion for Final Approval
2 of Class Action Settlement and Judgment Thereon (“Final Approval Order”), which, together with
3 the May 8, 2023 Stipulation to Amend First Amended Stipulation of Class Action and PAGA
4 Settlement and Class Notice (together, “Settlement,” “Agreement,” or “Settlement Agreement”),
5 the Settlement Agreement and exhibits annexed thereto, set forth the terms and conditions for
6 settlement of the Action.

7 Having reviewed the Stipulation to Amend Final Approval Order and Judgment and
8 Approve Supplemental Class Notice to the Class (“Stipulation”) filed on March 19, 2024, and
9 good cause appearing,

10 **THE COURT HEREBY ORDERS, ADJUDGES, AND DECREES AS FOLLOWS:**

11 1. This Order incorporates by reference the definitions in the Settlement Agreement,
12 and all capitalized terms used, but not defined herein, shall have the same meanings as in the
13 Settlement Agreement.

14 2. The Court amends the Final Approval Order, section C, and Paragraph 54 of the
15 Settlement Agreement to allow for the following stipulated settlement funding schedule:
16 Defendant shall make a good-faith payment in the amount of One Hundred Thousand Dollars
17 (\$100,000) within thirty (30) calendar days of entry of this Order and Judgment; payments of
18 Twenty Thousand Dollars (\$20,000) per month thereafter, and the balance of the settlement
19 amount payable on or before December 31, 2024. All payments are to be distributed by the
20 Settlement Administrator on or before January 10, 2025.

21 3. The Court approves the supplemental Class Notice to the Class of the revised
22 payment schedule, attached to the Stipulation as Exhibit B. All expenses associated with the
23 supplemental Class Notice to be borne by Defendant.

24 4. The Court sets a Non-Appearance Case Review re: Final Report re: Distribution of
25 Settlement Funds for Feb. 18, 2025 at 8:30 am with the Final Report to be filed
26 by Feb. 11, 2025. If there is unpaid residue or unclaimed or abandoned class
27 member funds and/or interest thereon to be distributed to Legal Aid at Work, Plaintiffs’ counsel
